INVOICES & INTEREST:

All invoices are due and payable within the approved terms from the date of our invoice. Service charges calculated at 2% per month, 24% per annum, will be charged on overdue accounts. RETURNS & CLAIMS:

All sales are final unless agreed otherwise in writing. Returns must be pre-authorized and are subject to an automatic 20% restocking charge. All shortages and damages claim must be made within 48 hours of delivery.

NSF CHECKS:

I/WE agree to pay Cuisivin (B & M Marketing) the sum of \$25.00 for each returned check. CDN. \$ for Canadian accounts and US \$ for US and overseas companies.

UNDERTAKING:

I/WE accept that Cuisivin (B & M Marketing) will remain the sole and only owner of all merchandise and goods delivered until total payment of same is received by B & M Marketing. I/WE have full responsibility of maintaining the goods, property of Cuisivin (B & M Marketing), insured until same is fully paid, otherwise I/WE assume sole responsibility for any loss incurred after their delivery.
